CORPORATE GOVERNANCE

- [1] Call notices for the Annual Shareholders Meeting (ASM) are sent at least 15 days in advance.
- [2] The Board meets regularly four times every year and holds extraordinary meetings whenever necessary. Meetings are called at least eight days in advance, informing the agenda to be discussed. Minutes of the meetings are published on the Company website.
- [3] Suppliers, clients, managers of entities providing services to the company, professionals and their spouses or relatives up to the second degree cannot be elected as independent directors. The Board meets at least four times a year, once every quarter.
- [4] The Audit Board does not include members of the Board of Directors, the Board of Executive Officers, or employees of Triunfo, or employees of any subsidiary or any group company, or the spouse or relative of managers of the Company.

- (a) Rio Guaíba, Rio Verde and Triunfo Participações e Investimentos did not grant leave in 2013.
- (b) At Aeroportos Brasil Viracopos, one man and one woman went on leave in 2014 and are expected to return in 2015.
- (c) At Concer, two employees took maternity leave in 2014 and are expected to return in 2015.
- (d) At Portonave, two employees took maternity leave in 2014 and are expected to return in 2015.
- (e) Triunfo Concebra had not yet completed 12 months of operations by the close of 2014.
- (f) Of the professionals that took maternity leave at Triunfo Econorte in 2014, one was expected to return in 2015.
